


Chester Northgate 1

- Award-winning Market with 30 stalls and over 7 million visits since opening
- Maray opening before Christmas
- Final F&B unit at advanced stage
- Six screen Picturehouse Cinema
- Multi-storey car park, with increasing usage

Chester Northgate 2

- Regeneration of Forum Shopping Centre, Gateway Theatre and Hamilton Place
- Appointed VINCI-ION preferred development partner in July
- Create a new residential community of 400+ homes
- Commence consultation in 2026 after signing of Pre-Development Agreement.



Chester City Gateway

 Centred around Chester Rail Station and vicinity

 Aims to deliver improved station experience, public realm, active travel, and new housing

• Includes a Cheshire Archives Centre currently being built on site of former Enterprise Centre.

Cultural Partnerships



As part of the Experiencing theme of Chester One City Plan:

- Delivered Chester Contemporary which was a visual arts festival utilising unique and unexpected spaces across the city - evolving into a Community Interest Company (CIC), formation of its board underway to drive future strategy.
- A Chester Creative Spaces Collective has been formed, with initial members including PACH, Visual Arts Chester, and the University. The group is collaborating with agents, Chester BID, CWC, and a creative CIC to explore available spaces in the city.
- Established a **Cheshire West wide Culture Partnership**, to develop a joined-up approach to campaigning for more engagement and investment in culture to increase the number and range of people able to create and experience culture, developing a cultural manifesto. - Exploring **young person led space** in the city, there has been ongoing engagement led by Storyhouse with young people and the project is evolving to explore scope and opportunities for a dedicated space within the city.

Chester City Centre

- Harrods' H Beauty expected opening February 2026
- Northgate Arena refurbishment expected opening spring 2026
- Council enabling development via disposal of Kirkton House site, for residential use with Pure Homes 31 apartments on five floors
- IKEA now open on Greyhound Retail Park
- Successful Purple Flag assessment.











Chester Movement Strategy

- A city-wide, vision-led plan for transport, which will be developed in partnership with stakeholders, communities, and political leaders.
- Builds directly on the 'Connecting' theme of the Chester One City Plan, translating longterm aspirations into a practical transport investment programme
- Aligned with the Local Transport Plan 4 (LTP4) and looking ahead to 2045, the strategy focuses on 2025–2030 priorities to support regeneration, growth, and sustainability
- Work has recently commenced, starting with a technical evidence base for the study and will run to mid-2026.



Chester Movement Strategy - Engagement

- CMS addresses movement at multiple scales (from regional access to city centre navigation) and includes targeted 'deep dives' into key locations and issues
- Explore practical solutions for challenges such as the future role of Inner Ring Road, Chester Park & Ride, and city centre accessibility, ensuring alignment with Chester's broader ambitions
- A comprehensive engagement programme is in development, to focus on shaping priorities, trade-offs and proposals for the future of the city's transport network
- We are committed to inclusive, ongoing dialogue to shape a strategy that reflects Chester's diverse needs and aspirations.



Dee House & Quicks Garage

- **Dee House:** Chester Historic Building Preservation Trust commissioned to take one final look at saving the facade and incorporating it into a potential redevelopment of the site. The report is nearing completion before a pre app submission process in early 2026.
- Quicks Garage: A prominent but constrained building on Lower Bridge Street which we hope a new sustainable use will come forward for; however, no buyer confirmed at present.








Local Plan

- Housing needs and locations for new homes
- Employment and retail development
- Where development should be restricted or protected
- Areas for shops, green spaces, and other facilities.



Local Plan

- Issues and options consultation took place over the summer with over 13,000 comments received
- Officers continue to work on the evidence base for a new local plan
- Chester Civic Trust comments were received and will be considered as part of next steps
- Current timeline is to carry out second round of consultation autumn 2026 with submission of plan for examination to government by the end of 2026
- A range of legislation and changes are still awaited so the above timeline is still subject to change.



Rising to the housing challenge

- Committed to increasing housing over 320 completed recently in Winsford and Ellesmere Port, and 367 consented in Winsford
- Proactively reviewing surplus assets in both urban and rural areas to bring forward housing development opportunities
- Engaging with developers to review sites they are considering for housing



Current housing targets and applications

- The Council has a target to provide 1,928 dwellings per annum (28,920 dwellings over 15 years)
- Over 12,000 homes currently being considered over pre-application and application stage
- Design code nearing completion with detailed conversations with highways
- All large-scale applications going through a design triage with a commitment to put additional resource to first planning appeal for an application refused on design grounds









Devolution

- Cheshire and Warrington are part of the Government's Devolution Priority Programme (DPP)
- Opportunity of more influence over the decisions that affect us, more powers and more funding
- Includes a 30-year Mayoral Investment Fund of £21.7m per annum and Mayoral Capacity funding of £4m from 2025-26 to 2028-29
- Floor not the ceiling



Devolution

A <u>Combined Authority Shadow</u>
 <u>Board</u> is in place, chaired by
 Councillor Louise Gittins

 It is made up of the Leaders and Deputies of Cheshire East, Cheshire West and Chester, and Warrington as well as appointed members

- The Combined Authority will be formally created by Parliament and is expected to be in place from March 2026
- Mayoral elections will take place in May 2027
